# **RECREATION COMMITTEE**

JULY 13, 2011

There was a meeting of the Recreation Committee held in the Municipal Council Chambers on Wednesday July 13, 2011. Present were Chair Margaret Whyte, Mayor Don Eady, Robert A. ## 1. CALL TO ORDER

Chair Margaret Whyte called the meeting to order at 7:05 P.M.

# 2. DECLARATION OF PECUNIARY INTEREST

There was no declaration of Pecuniary Interest by the members of the committee or staff.

It is an 800 number and does not require long distance so the Mr. McLaren may cancel the long distance coverage if the abuse continues.

CAO/Clerk Mackie McLaren reported that the Council has approved the committee suggestion to meet with Renfrew to review the user fees. Mayor Eady & Chair Marg Whyte will set up a meeting with Renfrew and whoever is our new Chair of Sports will attend with them.

# - HALL CLEAN UP AFTER MAJOR EVENTS.

CAO/Clerk Mackie McLaren reported that Nelson St. Michael has agreed to clean up the hall after each event and put away the tables and chairs to prevent unnecessary damage for a fee of \$50.00 per event over and above the \$250.00 monthly fee he already receives.

#### 6. DEPARTMENT REPORT

CAO/Clerk Mackie McLaren said he received a complaint this past weekend from Rilla St. Michael about the use of Confetti or metallic party sprinkles depicting Happy Anniversary, Happy New Year or Happy Birthday. They are very hard to clean up and would like the wording in our Rental agreement to reflect that they are banned on all occasions.

CAO/Clerk Mackie McLaren reported that the Niagara Fruit is our next fundraiser and we will have to prepare for this Kathleen Rogers called Lakelee Orchards this week but they requested that we call back in 2 weeks (July 25) as they cannot give us the appropriate information on prices, packaging and delivery as of yet. Their growing season is about two weeks behind this year. Last Year the fruit was delivered on the 22 of August and we had no advance notice of delivery.

Chair Whyte wanted to know what our course of Action is. Valerie Miller said that we call all the past customers on our list to get orders and give prices. Dave Bennett said that we should have everything delivered to the fire hall so that we have easy access and he will bring a fork lift for easy loading and unloading. He said that it was very difficult last year taking everything into the community centre, dividing and then having to carry it back out. Tim suggested that we make calls from community centre as some people were getting confused by people making calls from their home numbers.

Kathleen Rogers will call and get exact prices and packaging info and a delivery date. She will make up and order sheet and scripted instructions to follow when phoning so we all give the same information. We will set up a calling list, get approximately 6 volunteers calling- BaileyRogers, Kathleen Rogers, Marg Whyte and Sandy Black will call. Office staff will do some calling. We will contact the Fire Chief to see if we may use the fire hall on delivery day. Ralph and Gladys Miller will collect payments on delivery day. When placing our final order we should get a couple of extra cases to compensate for damaged fruit.

Chair Whyte noted that Jennifer Barr, Finance Manager is still working on our annual budget so there is no report yet. Ms. Barr will spend time distributing and renaming accounts so we will be able to identify them more clearly.

Tim McDonald would like to host another Bluegrass Event and asked Robert A. Johnston how much it would cost for the Spinney Brothers. They could be out of our price range. He will meet with Arnold Dickson & Bob Johnston to see what they can arrange.

Tim MacDonald would like to host a Fall Market in September under the Rink Roof. We would invite local vendors to come and sell their wares and produce. We will pick September 3, 2011, so as not to interfere with the fair date. Hours will be 7:00 am to 1:00 p.m. we will advertise for vendors in the Horton Corner in August.

We will have to check pricing to see if we will charge by vendor or by table and if we will supply the tables and how much we will charge. The Committee agreed that this was a good idea and said that he may go ahead and plan.

# - BOAT LAUNCH FEES - MEMBER COMMENTS

If it was for karaoke night or music related event then we would charge a fee of \$50.00. The money from these rentals would go into a separate account to cover the replacement cost of the system when it either gets old or breaks. We also need to label the micro phone to try to prevent it from disappearing.

Robert A. Johnston would like to know what is happening with the beach project. He will donate time to help complete the project but he cannot do it by himself. Fencing- Chair Whyte wanted to know what kind of a fence we were putting up. Would the fence be to keep beach goers off of the Ballantyne's and Welsh's property?

Mr. Johnston would like to see the ground asphalt graded and he will coordinate after the July 20 Public Works meeting. Chair Whyte noted that there has been no funds allocated in this year's budget for this but maybe they can find some for next year. Mayor Eady asked that this be added to the Public Works agenda for the next meeting.
