

**COMMUNITY POLICING ADVISORY COMMITTEE**  
**TOWNSHIP OF MCNAB/BRAESIDE COUNCIL CHAMBERS**

**JANUARY 16, 2012 - 7:30 P.M.**

There was a meeting of the Community Policing Advisory Committee held in the McNab/Braeside Township Council Chambers on Monday January 16, 2012. Present were Chair Brad McIlquham from McNab/Braeside, Glen Campbell from Horton, Bob Campbell from McNab/Braeside, Allen Dick from Whitewater Region and Glenda McKay from Greater Madawaska. Also present was Staff Sergeant Colin Slight and Secretary, Christina Mulcahey.

1. CALL TO ORDER

Chair Brad McIlquham called the meeting to order at 7:30 p.m.

2. MINUTES OF LAST MEETING

The Committee reviewed the minutes from the November 21<sup>st</sup> 2011 Committee meeting.

3. BUSINESS ARISING

Glen Campbell reported that signs were put up at the Lochwinnoch Road intersection in Horton Township, but then unfortunately stolen. Since then, more signs have been put up and they hope that these new high visibility signs will help prevent accidents that have been occurring at this intersection. Bobby Campbell from McNab/Braeside Township said that the Public Works Department will also be putting up new signage on their side of the intersection.

Allen Dick reported that he had not seen the Speed board out on the West side of Cobden as requested. Staff Sergeant Slight said he would check on that and if it wasn't put out he would request it again.

Staff Sergeant Slight reported that a few batteries had to be replaced in the Speed board but nothing major.

#### 4. COMMUNITY POLICING REPORT

Staff Sergeant Slight handed out the CPAC report for January 2012. He asked for input from the Committee on the Local Initiatives. All Committee members agreed that they were satisfied with the current Local Initiatives.

The second page of the report listed statistics for an overall 2011 year. The Committee reviewed the statistics. Glen Campbell asked what the most common was under the miscellaneous category and Staff Sergeant Slight replied Police Assistance or Information. The Committee then asked for a more detailed description of what the categories were. Staff Sergeant Slight said he would provide the Committee with the detailed categories.

#### 5. SPEEDBOARD

There was no report available.

#### 6. COMMITTEE INPUT

Allen Dick asked about patrols on Muskrat Lake in Whitewater Region during the bass tournaments that often occur. Staff Sergeant Slight asked Allen to provide him with dates and times for the tournaments. He informed Allen that Darren Chaplin is still the Marines Operator for the 2012 season.

Glenda McKay mentioned that there was a request in Greater Madawaska for a stop sign on a side road. She would like Staff Sergeant Slight to comment on this. Glenda was going to email Staff Sergeant Slight more detailed information.

Bobby Campbell asked Staff Sergeant Slight what he thought about speed bumps and if they are any help to control speed. Staff Sergeant Slight said it depends on where and how you use them but he has heard good reviews on them and seen them being used efficiently. He said if you are going to use them make sure there is good signage. Also, to look at the liability issues that could arise.

Glen Campbell spoke about the speeding issues in Horton Township. He asked that whenever possible patrols be carried out in the Township.
