

COMMUNITY POLICING ADVISORY COMMITTEE
TOWNSHIP OF MCNAB/BRAESIDE COUNCIL CHAMBERS

JUNE 17 2013 - 7:30 P.M.

There was a meeting of the Community Policing Advisory Committee held in the Township of McNab/braeside Council Chambers on Monday June 17th 2013. Present were Chair Brad McIlquham from McNab/Braeside, Glen Campbell from Horton, Allen Dick from White Water Region, Aldene Styles from McNab/Braeside and Glenda McKay from Greater Madawaska. Also present was OPP Staff Sergeant Colin Slight and Committee Secretary Christina Mulcahey.

1. CALL TO ORDER

Chair Brad McIlquham called the meeting to order at 7:30 p.m.

2. MINUTES OF LAST MEETING

The Committee reviewed the minutes from the April 22nd 2013 Committee meeting.

3. BUSINESS ARISING FROM MINUTES

Glen Campbell informed Staff Sergeant Slight about the upcoming Horton events including the July 6th Family Fishing Derby and the Annual Bluegrass Festival the weekend of July 13th 2013.

Glenda McKay informed Staff Sergeant Slight about the County Festival coming up at the Calabogie Peaks July long weekend. She also noted about the Festivities on July 1st. Glenda reported that the speeding on Highway 508 has begun again as well due to the Calabogie Motorsports Park being a busy attraction.
