

## COMMUNITY POLICING ADVISORY COMMITTEE

### TOWNSHIP OF HORTON COUNCIL CHAMBERS

**AUGUST 26 2013 - 7:30 P.M.**

There was a meeting of the Community Policing Advisory Committee held in the Township of Horton Council Chambers on Monday August 26<sup>th</sup> 2013. Present were Chair Brad McIlquham from McNab/Braeside, Glen Campbell from Horton, Allen Dick from White Water Region, Aldene Styles from McNab/Braeside and Glenda McKay from Greater Madawaska. Also present was OPP Staff Sergeant Colin Slight and Committee Secretary Christina Mulcahey.

#### 1. CALL TO ORDER

Chair Brad McIlquham called the meeting to order at 7:35 p.m.

#### 2. MINUTES OF LAST MEETING

The Committee reviewed the minutes from the June 17<sup>th</sup> 2013 Committee meeting.

#### 3. BUSINESS ARISING FROM MINUTES

Glen Campbell commented on the good organization of the Police traffic control being done in Cobden during the major construction. Allen Dick also said he has received good feedback from residents in the area.

Brad McIlquham said that he received good response from the Saturday when Police presence was near the Landfill Site.

#### 4. COMMUNITY POLICING REPORT & SPEEDBOARD REPORT

Staff Sergeant Slight reviewed the Community Policing report with the Committee. He noted that he will be looking for input for the new business plan starting in 2014. Staff Sergeant Slight also reviewed the Speedboard Report and Crime Statistics for June & July 2013.

Staff Sergeant Slight handed out a copy of the OPP Community Satisfaction Survey for 2013 Renfrew (and Arnprior) Detachment. He

reviewed it with the Committee. Overall Staff Sergeant Slight said he was pleased with the outcome.

#### 5. COMMITTEE INPUT

At this time Staff Sergeant Slight informed the Committee that Chair McIlquham was asked to be on a selection panel for the new position of Inspector due to the joining of Renfrew and Arnprior detachments. He noted that applications have already been sent in and the process is underway.

Glenda McKay requested the speed-board be placed on Lanark Road just as you are leaving the village of Calabogie.

Glenda also questioned the presence of Police at certain events/festivals that are held. She asked if the Township absorbs the costing for their presence and vehicle use. Staff Sergeant Slight said that for major events the organizer would pay for the service requested. Glenda said she believes that private events and festivals should be charged for the use of the OPP vehicle as well.

Aldene styles said there is a problem with speeding on Campbell Drive in McNab/Braeside from the Highway 17 towards Osborne.

Glen Campbell informed Staff Sergeant Slight that a Roads Survey was sent out to all residents in Horton Township. The comments came back were some directed towards speeding. Glen said he will forward the results to Staff Sergeant Slight when we receive them.

Brad McIlquham noted that the WABA Museum Committee has requested that a patrol car go through the Museum when in the White Lake area.

#### 7. ANNUAL COMMITTEE FEES – DISCUSSION

The Committee had small discussion on the annual Committee fee again. The Committee is interested in seeing prices for new speed signs. Staff Sergeant Slight will do some research and email some information to the Committee members.
