

COMMUNITY POLICING ADVISORY COMMITTEE
TOWNSHIP OF WHITEWATER REGION COUNCIL CHAMBERS

OCTOBER 21 2013 - 7:30 P.M.

There was a meeting of the Community Policing Advisory Committee held in the Township of Whitewater Region Council Chambers on Monday October 21st 2013. Present were Chair Brad McIlquham from McNab/Braeside, Glen Campbell from Horton, Allen Dick from White Water Region and Aldene Styles from McNab/Braeside. Also present was OPP Staff Sergeant Colin Slight and Committee Secretary Christina Mulcahey. Absent was Glenda McKay from Greater Madawaska.

1. CALL TO ORDER

Chair Brad McIlquham called the meeting to order at 7:40 p.m.

2. MINUTES OF LAST MEETING

The Committee reviewed the minutes from the August 26th 2013 Committee meeting.

3. BUSINESS ARISING FROM MINUTES

There was no business arising from the minutes.

4. COMMUNITY POLICING REPORT & SPEED BOARD REPORT

Staff Sergeant Slight reviewed the Community Policing report with the Committee. He reviewed the school visits and Detachment Calls for Service Chart. He noted that Greater Madawaska calls were up in July (85 calls) and August (76 calls) as the average is 52. September the calls were back to 55 near average.

Chair McIlquham asked if there was any information on the OPP costing. Staff Sergeant Slight informed the Committee that there are Information Sessions coming up. The closest two are in Bancroft and Kemptville on November 4th and 5th 2013. Staff Sergeant Slight said he recommends

municipal treasurers/representatives go to the information session if available.

Staff Sergeant Slight mentioned there are new deer crossing signs on Highway 17. November is the "Speeding Costs You Deerly" Campaign. He noted that they are working with the County to also have some put up on County Roads as well.

At this time, Staff Sergeant Slight briefly reviewed an Information Package that was put together by Inspector Springer, Regional Traffic and Marine Manager, on the "SpeedSpy". The Committee had requested information on these speed statistic radar units. The cost of this unit would be roughly \$2600.00.

5. COMMITTEE INPUT

Allen Dick noted that there was some trouble with the park but that has seemed to resolve itself. He also noted that the construction on Highway 17 in Cobden is almost complete.

Aldene Styles informed Staff Sergeant Slight that there is an issue with speeding in the village of Glasco. The issue seems to be times when people are heading to and from work. She requested that the Speedboard be placed in the village.

Glen Campbell asked Staff Sergeant Slight about the Cotieville issue with the CP Trail. Staff Sergeant Slight said they have talked to two residents in the area and also talked to CP about erecting more "No Trespassing" signs.

Glen also informed the Committee that Horton is working with the snowmobile club to clean up the trail from Yantha Road to Renfrew. The snowmobile club has submitted a grant application to put up gates along the trail. It is an 11 km trail that could be used for recreational purposes. Glen said Horton's Walk-a-thon could possibly be held on the trail once its cleaned up.

7. ANNUAL COMMITTEE FEES – DISCUSSION

The Committee agreed to continue the \$200.00 annual fee. The Committee Secretary will send out invoices this month to each municipality.

The Committee is interested in the purchase of a new "SpeedSpy" device to eventually replace the current SpeedBoard that collects speeding data.

The Committee agreed to meet at **7:30 p.m.** on **Monday December 16th 2013** in the Township of **Greater Madawaska** Council Chambers.
