

COMMUNITY POLICING ADVISORY COMMITTEE
TOWNSHIP OF MCNAB/BRAESIDE COUNCIL CHAMBERS

JANUARY 19, 2015

There was a meeting of the Community Policing Advisory Committee held in the Township of McNab/Braeside Council Chambers on Monday January 19th 2015. Present were Hal Johnson, Tom Peckett, Jamey Larone, Glenda McKay. Inspector Colin Slight and S/Sgt Paul Chambers from the Renfrew OPP Detachment and Committee Secretary Christina Mulcahey.

Appoint Committee Chair – Inspector Slight called for any nominations for the Committee Chair. The Committee decided to defer this discussion till later in the meeting.

1. CALL TO ORDER

Glenda McKay called the meeting to order at 7:30 p.m.

2. MINUTES OF LAST MEETING

The Committee members reviewed the minutes from the October 20th 2014 Committee meeting.

Moved by Hal Johnson Seconded by Tom Peckett

That the Minutes of the October 20th 2014 Committee Meeting be adopted as read.

Carried.

3. BUSINESS ARISING FROM MINUTES

Glenda McKay (who was previously on the Committee) reviewed the minutes with the new Committee members. Committee members discussed the use of the Speedboard and how valuable it actually is. Inspector Slight said the speedboard was originally purchased by all four municipalities and used by the OPP detachment. However, he does not have enough resources to continue deploying the speedsign as often as this committee wishes. Inspector Slight informed the committee that other municipalities have shared a speedboard and deploy amongst themselves. The Committee discussed a few options such as the OPP continuing to maintain and operate or the four municipalities take control.

The Committee agreed to add this item to the next Committee meeting Agenda.

4. COMMUNITY POLICING REPORT

Colin Slight handed out the 2014-2016 Action Plan for the Renfrew Detachment as well as the 2014-2016 OPP Strategic Plan. He reviewed these documents with the Committee members.

5. COMMITTEE INPUT

The Committee discussed the need to continue a CPAC Committee.

Inspector Slight reviewed the purpose of this Community Policing Advisory Committee (CPAC) suggesting that it continues to have numerous benefits. He noted that One or more municipalities served by the same Ontario Provincial Police detachment that provides police services “may” establish a community policing advisory committee. However, should one or more municipality opt out of the committee the benefits would be less.

Inspector Slight reviewed the Ontario’s Mobilization & Engagement Model of Community Policing. A copy of this document was provided to each Committee member in attendance. He referred to page 12 of the Action Plan which is a List of Priorities for 2014-2016.

Glenda McKay, Mayor of Greater Madawaska said she would like to see Inspector Slight come to a future Council meeting. Inspector Slight said he would agree to make a presentation to each Municipalities Council on the Action Plan and involvement with the OPP. The Committee members agreed this would be beneficial. There was discussion.

Moved by Jamey Larone, Seconded by Hal Johnson

That the Community Policing Advisory Committee request each respective Council to welcome a presentation by Inspector Slight at a future Council meeting and to continue involvement with this CPAC Committee.

Carried.

6. 2015 COMMITTEE FEES & ACCOUNT BALANCE

The Committee reviewed the account balance statement provided by the Committee Secretary. There was brief discussion on the 2015 Committee Fees and it was decided not to invoice municipalities for this year as there was sufficient funds in the account but will discuss at a future meeting.

7. APPROVE INVOICE – 2014 SECRETARY SERVICES

Moved by Hal Johnson , Seconded by Tom Peckett

That the Committee approves to pay invoice # 75-14 in the amount of \$281.53 to the Township of Horton for the 2014 CPAC Committee Secretary Services.
