

COMMUNITY POLICING ADVISORY COMMITTEE

TOWNSHIP OF GREATER MADAWASKA COUNCIL CHAMBERS

AUGUST 17 2015

There was a meeting of the Community Policing Advisory Committee held in the Township of Greater Madawaska Council Chambers on Monday August 17th 2015. Present were Chair Jamey Larone (Horton) Hal Johnson (Whitewater Region), Tom Peckett (McNab/Braeside), and Glen MacPherson (Greater Madawaska). Also present was OPP Inspector Colin Slight and Sgt Paul Legault; and Committee Secretary Christina Mulcahey.

1. CALL TO ORDER

Chair Jamey Larone called the meeting to order at 7:30 p.m.

4. MINUTES OF LAST MEETING

The Committee members reviewed the minutes from the June 15th 2015 Committee meeting.

5. BUSINESS ARISING FROM MINUTES

6. PRESENTATION – MUNICIPAL POLICING BUREAU – OPP COSTING

Sgt. Paul Legault was present to provide an opportunity for everyone to possibly improve their understanding of the billing model and get answers to any lingering questions that they might have in this regard. Sgt. Legault said the policing bureau is trying to reach out to all CPAC committees to address any concerns or unanswered questions. He noted there is also a lot of information available online now.

Sgt. Legault made his verbal presentation on the new billing model. He stated that 60% of the billing is a base cost and the rest being based on calls per service. This is a more accurate and fair system. He informed the committee that the bills are calculated over a 4 year period with the average occurrences. For instance, the 2015 billing will be based on the average for 2010, 2011, 2012 and 2013. There was more discussion with Committee members. Inspector Slight said he would send out a scanned copy of the individual 2015 Billing Statements as hand delivered to the Township offices in late September 2014. Hopefully, as follow-up to Sgt Legault's discussion points, a careful read through the package will answer most questions and provide a clearer understanding of the current billing model.

Chair Larone thanked Sgt. Legault for his presentation.

7. COMMUNITY POLICING REPORT

Inspector Slight handed out a statics report for the individual municipalities. The Committee briefly reviewed. Inspector Slight reported there are no major issues to report on.
