# SPECIAL COUNCIL MEETING

#### JANUARY 29, 2007

There was a Special Council Meeting held in the Municipal Council Chambers on Monday January 29, 2007. All Members of Council were present. Deputy Reeve Hall left at 5:00p.m.

#### 1. CALL TO ORDER

Reeve Johnston called the Meeting to order at 4:30 p.m.

## 2. DECLARATION OF PECUNIARY INTEREST

There was no declaration of pecuniary interest.

## 3. ONTARIO INFRASTRUCTURE INVESTMENT INITIATIVE

## Ed Vickers Report – Estimated Work and Cost

The Council reviewed Ed Vickers, of Stantec Engineering, estimated cost of \$360,000 to upgrade and pave Pinnacle Road, from Price Road to Garden of Eden Road. Council discussed this Report.

# **Application Document**

Council reviewed a three hundred word description of the Program and a five hundred word statement on the benefit of this work to the Community, as required as part of the Application. Council discussed the possibility of contributing to this Program as an encouragement to the Province to approve it. After discussion they agreed that they would include in the current Budget the ditching estimated at \$25,500.00 and the culverts estimated at \$7,000.00 for a total of \$32,500.00

# 4. SPORTS EQUIPMENT AT COMMUNITY CENTRE – REVIEW QUOTES RECEIVED

Council reviewed two quotes received by the Recreation Committee for portable basket ball nets, volley ball nets, floor hockey frame and net.

Sports System Canada Inc, represented by Matt Mould of Almonte, \$6,083.00 includes shipping, setup and 240 pounds of ballast weight for the portable basketball nets.

## Ontario Gym & Sports

\$5,031,85

Does not include installation, lesser quality floor hockey frame, does not include basket ball ballast.

Council discussed the differences and after discussion agreed that the cost of set up and the cost of the ballast, which are not included in the Ontario Gym & Sports quote make the Sport System Canada quote the cheapest in the long run. After discussion the following resolution was passed.

#### Moved by Bob Kingsbury, seconded by Dave Bennett

Resolution No. 07-053

That Council accept the quote of Sports System Canada Incorporated in the amount of \$6,083.00 plus tax for the supply of Micro Z portable basket ball units, including shipping, assembly, delivery and setup and 240 pounds of ballast, one official sized volley ball net, and two official floor hockey frames, including nets, floor savers and assembly.

#### **Shuffle Board Supplies**

Council also received a quote from Dom Sports of Toronto, who specialize in Shuffle Board equipment, that came in following the Recreation Meeting. They recommend that we purchase shuffle board sets at \$185.95 a piece, plus tax, they also suggest a disc rack \$14.95 times two, and a scoreboard \$79.50 times two. The CAO/Clerk was to contact the Company to see if we need to have the Shuffle Board beads, or disc wax or sweepers if we are playing on a waxed tile floor. If we do then this would be part of the required supplies.

Resolution No. 07-054

That Council purchase the necessary shuffle board supplies from Dom Sports, which would include two Dom-91 Pro Set Shuffle Board equipment at \$185.95 each, two disk racks at \$14.95 each and two score boards at \$79.50 each. Further that if Shuffle Board beads and sweepers are required, they will be added to this purchase.
