3. RECOMMENTATIONS FROM FINANCE COMMITTEE

Purchase of Two Cubic Yard Demo Sander - Public Works Capital

That Council, on recommendation of the Finance Committee, agrees to purchase a two cubic yard sand spreader from Renfrew-Rent-All at the quoted price of \$4,000.00 plus tax.
