Recreation Committee March 24, 2009 Meeting Minutes

Councillor Kingsbury, chair of Recreation reviewed the Minutes.

Offer of Employment – Program Manager Position

Councillor Kingsbury reported that the Joint Meeting of Recreation and Human Resources Committee had gone well and they agreed to offer a contract to Julie.

The CAO/Clerk read an resolution he had prepared offering Julie \$15.00 per hour for probation increasing to \$16.00 per hour after probation. However, at the interview \$20,000 was offered, which Julie was expecting. Deputy Mayor Hall and Councillor Eady felt she should receive the money that was offered. Councillor Kingsbury was in favor of the lower amount, so there would be funds available to cover travel, vacation and overtime.

Councillor Bennett suggested that it be a straight contract for \$20,000 and she be responsible for tax and deduction.

After a lengthy discussion it was agreed that the CAO/Clerk would speak to the Township lawyer about a contact position and also with Julie Hawley to see if she was agreeable. The Recreation Committee would then have a Special Meeting to approve the contract and hiring Julie Hawley as Recreation Manager Programmer.

CNR Trail Bridge Damage

Jeff Schruder reported some of the timbers are rotten on the CNR Trail bridge near RONA. He suggested using some of the Hydro Stop Logs that are at the Landfill Site to repair the bridge. The steel underneath is fine.

Deputy Mayor Hall asked who is responsible for the trail?

The CAO/Clerk reported that the Snowmobile Club is responsible for winter maintenance. Deputy Mayor Hall suggested contacting the Snowmobile Club to see what they are willing to do.

Councillor Eady said the Waste Management Committee would donate twelve logs.

Council agreed to postpone discussion about the Beach until the May Council Meeting.

Moved by Dave Bennett, seconded by Don Eady Resolution No. 09-92

That Council authorizes replacement of the deck on a bridge on the CN Trail between RONA and the Town of Renfrew using "stop log" timbers the Township has stored at the Landfill Site. The Snowmobile Club is to be asked to supply labour and to assist with fundraising through a dance at the Community Centre.

Councillor Bennett suggested using this company as they had the design and engineering done, if we apply for the government grant the program should be "shovel ready". Deputy Mayor Hall and Councillor Eady suggested asking Jeff Schruder to investigate other companies and get more information.
