By-law to keep Farm Animals on Farm

The Morrisons who live on Eady Road presented a draft "Livestock Containment bylaw". Their neighbours have two horses who wander onto the Morrison property at all hours of the day and night causing physical damage and preventing the Morrisons from allowing their two dogs to go outside. The horses attack the dogs and one dog has been kicked. The neighbours who own the horses do not have an adequate fence around their property. The Morrisons have installed an underground electric fence around their property to keep their dogs in. They have contacted our Animal Control Officer, who has spoken to the owner of the horses, but the Township does not have a bylaw to cover this problem, which is why the Morrisons have made this proposal.

The CAO/Clerk reported that there is a standard Fence rule which requires property owners to be responsible for fences on their property 50/50 with neighbours and generally this works.

Mrs Vern Barr, a neighbour, spoke in support of the Morrisons.

Council agreed that the situation is intolerable and requested that the CAO/Clerk research Fence bylaws. Council also suggested referring the issue to the Planning and Public Works Committees.

Mayor Johnston thanked the Morrisons for attending and promised that the Township would look into the matter.
