# Public Works Report for June 2009

Jeff Schruder reviewed the Public Works Report. Chair Bennett asked about the roadside grass cutting, mentioning that Thompson Road needed to be done urgently.

The CAO/Clerk reported that he had received a call from Randy Thur, a Technician with the Renfrew County Public Works Department, who had called about a missing pin number on a section of Thompson Road, a survey would cost \$30,000 - \$40,000. The CAO/Clerk recommended waiting as the pin is not needed at this time.

Waste Management Committee Meeting June 18, 2009

Councillor Eady, chair of Waste Management reviewed the June 18, 2009 Minutes. Councillor Kingsbury asked if a note was being put on Tipping Invoices for the LFS, indicating that there would be a penalty on unpaid accounts.

Chair Eady suggested that a by-law is needed to do this and it was agreed that it be discussed at the next Committee of the Whole meeting.

### E-Waste

Jeff Schruder reported that he, Bill Yantha and Katie Turton (summer student) had loaded nine pallets and covered them with shrink wrap ready for pickup.

### Grinding

Jeff Schruder reported that he spoke to Fast Eddie (Grinding Company), who promises to come soon. Jeff reported that there has been a gain of about 50% space by reworking and compacting at the Landfill Site. The Certificate of Approval for the Landfill Site Expansion has been sent to the Ministry.

**Whereas** the Township of Horton own a landfill on Lot 17 Concession VI that operates under Certificate of Approval A412505 and is predicted to reach capacity sometime in 2010, and

**Whereas** the Township has reviewed alternatives for the provision of disposal services for municipal waste and has selected the expansion of their existing landfill as the preferred option for providing this service, and

**Whereas** the Township has requested their Consultants to prepare a Hydrogeological report and a Site Development, Operation and Closure report to support an application under the Environmental Protection Act for approval of the expansion (slightly less than 40,000 cubic metres), and

**Whereas** the Township has advised abutting landowners by letter that these documents are available for review at the municipal office and have presented these reports at a public meeting on May 5, 2009.

Be it resolved that the Township of Horton adopt the Consultant reports fir the expansion of the landfill and authorize the clerk to submit the application and supporting documentation to the Ministry of the Environment for environmental approvals.
