## 2009 Environmental Report – George Thompson

George Thompson was present to review his report. Responsibility for small drinking water systems was transferred on December 1, 2008 back to the Ministry of Health and Long Term Care from the Ministry of the Environment. George feels that operators will be happier, as they will now be dealing with Local Health Inspectors who understand the needs of the community.

George attended the 2008 Ontario Association of Sewage Industry Services Conference & Rural Waste Water Expo in Orillia in October and he felt there were more municipal people attending than in previous years. George had an opportunity to speak with Shelly Bonte-Gelok from MOE and Michael Payne from OMAFRA. George feels it is very important that Horton complete the two year Lime Stabilization Program so the results are accurate.

The CAO/Clerk reported that Ron Harnett from the Ministry of Health has booked the Community Centre in April for a presentation on the new regulations.

Councillor Bennett shared George Thompson's concern that the Ministry want to shorten the Lime Stabilization Trial Study - we want to do it properly. The Municipality was not at fault for the delays in getting the program started and needs the original time frame to complete the Study.
