### 1. CALL TO ORDER

## 4. OPEN ISSUES/REPORTS:

i. Bar Fridge & Recommendations for the replaced

Ms. Ryan reported that the new bar fridges that were ordered are in place
and functioning well. There was a request from the Manager of Public
Works for direction as to what to do with the old fridges recommending that
to sell them, not much money would be recovered, and are in need of repair.

Mayor Bennett ask that both replaced refrigerators be placed in the
Zamboni room until the canteen room that is ready to receive them is ready.

## ii. Rink

Ms. Ryan reported that there have not been many calls with regards to the rink being closed. Chair Humphries and Mayor Bennett stated that they each had a few calls, but the individuals understood and agreed as to why it was not open.

## iii. Participaction Grant

ii. Horton Recreation Association (HRA)

Mayor Bennett expressed that he would like to see the committee spend some time on reviewing the most recent draft of the (HRA) that was created a few years ago. During the pandemic he discovered that there could have been some grants and other funding avenues that could have been tapped into if the Community Centre were its own entity, and not part of the township. Chair Humphries stated that a delegation would have to come before council to present the plan. The Committee was asked to brainstorm individuals who have strengths in the various facets required to assist with creating a viable Constitution and would be willing to help. Chair Humphries directed Ms. Ryan to email out the 4<sup>th</sup> draft of the Recreation Constitution for members to review, recommend changes and discuss for the next meeting.
